SMA Reaches 1 Gigawatt of Solar Inverter Sales in Thailand

Niestetal/Bangkok, October 23, 2015—SMA Solar Technology AG (SMA) has achieved 1 GW of solar inverter sales in Thailand. Thailand is the fourth market in the APAC region where SMA has reached this milestone. SMA has been present in the country since 1998 and opened its subsidiary in 2011 to cater to the growing region.

"SMA's market leading position has been built on a reputation of state of the art, robust and reliable technology from Germany, backed by excellent local service," said SMA Thailand Country Manager Suntisuk Mathinapitak.
